The project "FPD Robotic E-Waste Recycling, eLoop, US" had the Stakeholders Consultation on 5 August 2024 at 3500E College Ave, State College, PA 16801, United States.

The start date of the project was on 21 April 2023 according to the document "Equipment handover document 21.04.2023". Therefore, the project is retroactive since the Stakeholders' Consultation was after the start date of the project.

The project does not meet the rule from the PRINCIPLES & REQUIREMENTS, version 1.2:

4.1.49 (b) Retroactive projects shall submit the required documents for preliminary review (time of first submission) within one year of the project start date. Retroactive Project submitted at a date later than one year from the project start date will not be eligible for Gold Standard certification.

The time of first submission for preliminary review is: 01/11/2024 which is later that 1 year.

3.1.1 | Deviation detail (to be completed by Project developer):

We like to describe below the fact that the project developer had strong actions related to prior consideration of the carbon credits, but due to operational and financial problems, they could not submit the documents for Preliminary review earlier, within one year.

The Project Developer has submitted on 17 January 2021 to Gold Standard the application with all documents to open a registry account and the open of the account was confirmed by GS on 06th January 2022 for Impact Registry and the confirmation for Sustain Cert is 06th January 2022.

The management vision of obtaining carbon revenues for their Project began on 3th August 2022, before the start date of the project when they contacting a consultant to develop a pre-feasibility study on CO2 emission certification.

The following actions have been done by the company in order to acquire carbon revenues before the start date of the project (21st April 2023). At the same time, after the start date of the project, continuous actions have been taking for the same purpose to obtain carbon credits and will be described in the table below:
