The deviation request is approved in accordance with the requirements stated in Section 6.1.3 of GHG Emissions Reduction and Sequestration Product Requirements. The PD shall ensure that the revised PoA crediting period start date is the earliest crediting period start date amongst all the VPAs included in the PoA. The PD shall perform either one of the following actions:

 Revise the crediting period start dates of VPAo1 (GS4965) and VPAo3 (GS6252) in accordance with the revised crediting period start date of the PoA or

ii. Voluntarily exclude VPAo1 (GS4965) and VPAo3 (GS6252) from the PoA Consequently, the POA shall submit a request for a design change, during or any time before the next verification and no later. In case the PD chooses option (i) above, the design change request shall include revision in the crediting period start dates of VPAo1 (GS4965) and VPAo3 (GS6252).

Precedent Statement:

The GS decision on this deviation request sets a precedent for PoAs operating under identical conditions. A PoA is allowed to revise its crediting period start date to a later date (which may be the crediting period start date of any VPA other than VPA1) if it can be demonstrated that VPA1 has not been implemented. The PoA shall ensure that the revised PoA crediting period start date is the earliest crediting period start date amongst all the VPAs included in the PoA. For VPAs having crediting period start dates before the proposed (new) crediting period start date of the PoA, the PD/CME shall perform either one of the following actions:

- a) Revise the crediting period start dates of these VPAs in accordance with the proposed (new) crediting period start date of the PoA or
- b) Voluntarily exclude these VPAs from the PoA by following due process.

Consequently, the PoA and VPAs shall submit a request for a design change, during or any time before the next verification and no later. In case the PD chooses option (a) above, the design change request shall include revision in the crediting period start dates of the concerning VPAs. B. According to the GS4GG PoA requirement, item 3.1.2: "*The PoA crediting period* start date is the crediting period start date of the earliest VPA/CPA included in the *PoA*". Therefore, the start of PoA crediting period should be 15/02/2017 as in the above table.

¹ Please note that in the PoA DD or VPA DDs, the term "CPA" was sometime used because the PoA and VPA have been developed under GS4GG but using the CDM methodology AMS II.G and referred to the UNFCCC guidelines. In this PoA context, VPA and CPA have the same meaning

However, due to the lack of funding for distribution of ICS since Dec 2018, under VPA01 and VPA03, these VPAs are currently inactive but only the VPA04 (GS6746). Besides, there has been no VERs were issued to date under the proposed PoA, therefore, PP would like to request for changing the current start date of PoA crediting period (15/02/2017) to 25/01/2018 which is the starting date of crediting period of its VPA04 (GS6746).

3.2 | Assessment of the deviation:

Since there is no issuance taken place before the new proposed start date of PoA (25/01/2018), there should be no any conflict with the GS's requirements. In fact, the requested postponed period is less than 1 years therefore it is in line

with the UNFCCC standard that:

"234. The project participants of a registered CDM project activity are not required to

request approval from the Board for the following changes to the start date of the

crediting period of the project activity, but shall notify the secretariat of the changes

in accordance with the "CDM project cycle procedure for project activities":

(a) Bringing forward the start date up to one year earlier than that indicated in the

registered PDD, taking into account that the start date shall not be earlier than the effective date of registration of the project activity;

(b) Postponing the start date by up to one year, or by up to two years for a project

activity hosted by a least developed country, later than that indicated in the registered PDD."
