3 **Deviation detail**

3.1 | Description of the deviation:

3.1.1 | Deviation detail (to be completed by Project developer):

Afyon Enerji ve Gubre Uretim Ticaret ve Sanayi A.Ş., the project developer, in the light of recent COVID events and movement restrictions, requests the following exemption for not meeting the project transition deadline of November 23rd, 2021:

The project was under validation and was initial submitted for the design certification on 29/01/2015 and we have received the first round of the review comments from the GS, however project developer went into deep financial trouble and could not proceed with GS registration. After finding the financial normalcy due to unexpected and abrupt lockdowns and other forms of disruption caused by the impact of Covid-19 in Turkey, our offices have been intermittently closed, and travel to and from the office and the field has been halted and therefore the registration have been significantly delayed.

Our GS account which was managed by the independent consultant have gone incognito. To reactive the GS registration procedure we have appointed a new consultant on 03/09/2021.

The PP would like to register that it has not casually pursued qualification for Gold Standard carbon credits and in fact has always considered them a major factor in the success or failure of the projects. This is borne out by the fact that the PP contracted a VVB and appointed a new consultant for the project. Furthermore, the PP has held local stakeholder consultation meetings in line with the Gold Standard requirements in order to facilitate successful qualification for Gold Standard carbon credits.
