3.1.1 | Deviation detail (to be completed by Project developer):

A terrible earthquake happened in Nepal on 25/04/2015. The project area was heavily affected by this. More than 50 percent of all so far built stoves had been severely damaged and were out of operation. The project set the duration of the second monitoring period therefore from 01/04/2014 to 24/04/2015.

Subsequently a suspension of the crediting period for the project was requested from Gold Standard:

- Suspension duration from 01/05/2015 until 30/04/2017: The request was submitted on 26/01/2016 and approved on 10/02/2016.
- Prolongation of the suspension period from 01/05/2017 until 30/04/2018: The request for was submitted on 09/04/2018 and approved on 12/04/2018.

Hence, the approved suspension period lasted for complete 3 years.

My personal mistake was that I have neglected 6 days from 25/04/2015 to 30/04/2015. I added these days neither to the 2nd monitoring period nor to the suspension period. This was my fault. I did this to get full years of suspension. Otherwise the suspension time would be 3 years and 6 days and that would raise perhaps some other problems. For instance, the whole crediting of the project would then last until 06/01/2026 and the annual fees would have been calculated different. Maybe this would also lead to confusion.

#### **Deviation Request**

My deviation request for the project is to include the missing gap of 6 days from 25/04/2015 to 30/04/2015 into the approved suspension period from 01/05/2015 until 30/04/2018 and to re-approve the duration of the suspension period from 25/04/2015 until 30/04/2018.
