3.1 | Description of the deviation:

3.1.1 | Deviation detail (to be completed by Project developer):

GS11662 Gazişehir LFG Utilization Project is a retroactive project activity since the Stakeholder Consultation is conducted after the start of project activity as defined under par 4.1.42 of Principles and Requirements.

The starting date of the project activity is determined as 11.05.2021 in line with the definitions and requirements of GS. PP has submitted **key project information** (as per par. 5.1.4) on 09.05.2022 in line with the 1 year rule (as per par. 4.1.49.(b)) however uploaded signed Terms and Conditions on 25.05.2022 and paid the fee for the preliminary review on 16.06.2022. Detailed timeline of the project activity is as follows:

With regards to communication (email) with Sustain Cert on 27.07.2022, PP was requested to clarify and send a deviation form addressing the following requirement:

"Preliminary review submission **is considered 'submitted'** when the Project Developer has: (a) signed and submitted the Terms and Conditions AND (b) submitted the Project Documentation AND (c) paid the fee for the Preliminary Review, where required (para 5.1.7, Principles and Requirements)"

PP was also requested to provide clarification on date of fee payment.

The PP kindly requests that the project activity is considered in compliance with 4.1.49(b) and proceed with retroactive project cycle.

3.2.1 | Deviation assessment (to be completed by Project developer):

PP wishes to present the following main arguments for consideration to support a positive assessment outcome.

Compliance with core principles and requirements of Gold Standard:

Although administrative documents have been submitted to gold standard after 11.05.2022, key project information including the **draft PDD and Local Stakeholder Consultation Report** was submitted to Sustain Cert on a timely fashion. This assures compliance with par 4.1.49(b); par 5.1.1(a); par 5.1.3; par 5.1.4 and par 5.1.8 which require submission of Draft PDD and LSC report as key documents. This indicates strong evidence on prior consideration of the project activity and PP's dedication to receive GS registration.

Requirement of Par. 5.1.7:

PP interpretation on Par 5.1.7 of GS4GG Principles and Requirements was that it governs conditions on **when a Preliminary Review starts** within GS rather than providing a definition on "submission date" or a conditionality on submission is considered "submitted or not".

Clarification on partial submission of documents to Sustain Cert:

GS11662 was established on 09.05.2022 and is listed under the general account of CEV Enerji Üretim Sanayi ve Ticaret Limited Şirketi (CEV account). However CEV account was registered by a consultant company on behalf of project owner as a

practical solution to follow-up a issuance of another project. The need to transfer the main account to the project owner has caused PPs to upload documents partially. Key project documentation (LSC report and Darft PDD) was uploaded before solving the registry transfer to comply with 4.1.49. Please also take into account the above clarification on interpretation of the PP on Par. 5.1.7.

Delayed payment on Preliminary Review Fee.

The payment can only be made by the PP once an invoice is issued by Sustain Cert. PP only received an invoice for GS11662 on 08.06.2022 which was immediately processed and paid on 16.06.2022.

Note: Although the Invoice date was 02.06.2022, this invoice was not received by the PP. An invoice was received on 02.06.2022 however it was for GS745. One possible reason for communication problems could have been the transfer of account and change in contact information.

The PP kindly requests that the project activity is considered in compliance with 4.1.49(b) despite submission of administrative documents and requirements (signed T&C and invoice payment) were not satisfied.
