3.1.1 | Deviation detail (to be completed by Project developer):

Çaypınar Wind Farm Project, Turkey (GS7622) is registered under Gold Standard as a large-scale wind power plant with 24 MWe installed capacity on 21/06/2022. The project started operation on 29/10/2020. The project is preparing for its first performance review.

As per rule 5.1.42 which is "An annual update report shall be provided to GS -when design certification is achieved- for each monitoring year by the end of next calendar year for which verification is not completed" project was required to submit annual update reports before the end of the following year.

Unfortunately, the PP was not fully aware an Annual Update Report was required for the year 2020, since the project is listed on 02/06/2020 and started operation on 29/10/2022 and only operated 2 months in 2020. The project continued operation during this period and achieved design certification on 21/06/2022.

The project did not request or benefit from any exemptions up to date, and there is no adverse impact associated with the project.

PP acknowledged the importance of annual update reports and will provide future reports at the latest by the end of the following year as stipulated in Principles & Requirements in the future.

We kindly request the 2020 annual update report to be registered retroactively with this deviation form.
