The verification site visit of the project activity was planned on 06/03/2023. Due to devastating earthquakes in Turkey on 06/02/2023, unfortunately, many people passed away and still many of them are trying to survive. The project is in Hatay and the city is the most affected place by the earthquake. Specialized civilian and military teams are still going to the region to rescue people who have been affected by the disaster and take aid for the needs. The airports (Adana and Gaziantep) close to these sites are all "gone" and their remains are solely used for support-flights for quite a while.

We thought to postpone the verifications however we don't know how much time it would take for the region to be made up and really "good". People are also worried about epidemic illness as tetanus and cholera.

We do not want to prevent any of effort of helping people for victims and also want to protect safety of VVB and consultant teams, we'd like to request the site visit to be executed "remotely".
