The project developer through this submission would like to <u>request an extension to</u> <u>complete the inclusion process of the regular VPA beyond 2 years.</u>


In line with clause, 4.9.3(d) of the Stakeholder's requirements, there are certain requirements to be met for a regular VPA to comply with grouped consultation rules. The PD is following clause (A) to (C) and does not comply with only clause (D) i.e.

VPAs are included in the **PoA within two years of the first physical meeting conducted** for grouped consultation.

The dates of the grouped consultations are stated below:

Shiwang'andu, Muchinga province - **26/02/2021**Bombwe, Central province - **05/03/2021**Mupelekese, Central province - **09-03-2021**

and the documentation for the regular case VPA was submitted for inclusion to SC on **24/02/2023** i.e., **within 2 years of the first consultation**. (Please see screenshot below)



The PD was expecting SC to conduct the inclusion process for this VPA in line with latest PoA rules, but we were informed by SC that we are not eligible for this process since our PoA was certified as per version 1.0 of PoA rules. The PD had to then go through a normal inclusion process inclusive of Preliminary review and our now undergoing inclusion process through an external VVB, which is essentially the reason due to which there has been a delay in completing the inclusion process for the regular VPA.
