3 **Deviation detail**

3.1 | Description of the deviation:

3.1.1 | Deviation detail (to be completed by Project developer):

This deviation request is submitted to the Gold Standard regarding the exemption needed for Kiyikoy WPP Project (hereon referred to as "the project") from article 3.1.12(b) of the Gold Standard TRANSITION REQUIREMENTS (publication date: 16/08/2021, version 2.0) document. The project was listed under Gold Standard with ID 1372, as a large-scale wind power plant with 44 MWe installed capacity on 27/03/2014.

As per paragraph 3.1.12 of the Transition Requirements (version 2.0) document, "Projects/PoAs that are under listing or validation process at the time of launch of GS4GG (01/07/2017) shall follow, as applicable, the requirements, procedures, and

timeframes listed below to achieve Design Certification under previous versions of the Standard:

- a) Such Projects/PoAs must have engaged a VVB and shall submit the request for registration/design review before 23/11/2021. Such projects/PoAs shall transition to GS4GG at the time of first verification after 23/11/2021, and
- b) For such projects/PoAs,
- The Project Developer (PD)/Coordinating/Managing Entity (CME) shall demonstrate that "continuing and real actions were performed to secure Design Certification."

The applicable GS standard version is GS Version 2.2 VER, and the project was listed on 27/03/2014. Therefore, we would like to indicate that the requirements given in the 3.1.12 paragraph of the Transition Requirements introduced on 16/08/2021 mentioned new retroactive rules for all existing GS projects at that time. However, we would like to bring to your attention an issue regarding certain projects with special status that we believe may be impacted negatively by the current requirements, which was not fair, especially for the ones whose ownerships changed well after the GS application of the project. We understand that the standard requires all projects to meet certain criteria and comply with specific requirements. However, this project has undergone a change in ownership, which we believe may present challenges in meeting these current requirements. We understand that the standard requires certain actions and correspondence to be completed within specific timelines to ensure that the project meets the necessary criteria for carbon certification. However, no previous communications done by the previous owner can be accessed by the new PP. We believe that it would be unfair to penalize the project for a situation that is beyond the current Project Proponent's control and may impact the project's ability to comply with the current requirements.

The project had a change in ownership on **02/03/2020** as can be seen in the evidence document. Then, Carbon Consultancy Agreement has been signed on **17/08/2021** with Life İklim ve Enerji. The new Project Proponent has taken swift action to address any issues or challenges that may impact the project's compliance with the current requirements. We believe that this proactive approach demonstrates a strong commitment to the reduction of carbon emissions and should be recognized by GS.

To summarize, the new Project Proponent is facing a challenging situation due to several factors. Firstly, the project changed ownership on 02/03/2020, and the new Project

Proponent has not been able to access any previous communications related to the project. This lack of information has made it difficult for the new Project Proponent to fully understand the project's history and comply with the current rules. Secondly, new retroactive rules were introduced on 16/08/2021 that require all existing GS projects to comply with the requirements given in the 3.1.12 paragraph of the Transition Requirements. This has added an additional burden for the new Project Proponent to ensure compliance with the new rules.

We kindly request, with this deviation request form, an exemption from article 3.1.12(b) of the Gold Standard TRANSITION REQUIREMENTS (publication date: 16/08/2021, version 2.0) document to acknowledge the efforts of the new PP to maintain the project's carbon rights. This way, the project validation process will continue without being liable for any sort of documentary evidence that can be found in the aforementioned Gold Standard document.

We kindly request your understanding and assistance in this regard.
