The project developer is requesting the delay to a physical site visit requirement due to ongoing violence and regional tension in the project area and a deviation from Section 3.1.1 of the Site Visit and Remote Audit Requirements and Procedures Version 1.0.

The Amhara region of Ethiopia continues to see ongoing political and military tension.

The central government's announcement of planning to dismantle and disarm the regional forces met with significant violent protests in major cities and towns. This has lead to the loss of life for two foreign aid very workers recently.

Our project partner in the region has expressed concerns for the safety of any external or foreign attending auditors should a physical site visit have been pushed for. We have agreed to submit a deviation request as part of the ongoing Verification review and plan a remote site visit with the VVB and in a manner that is safe to be conducted.

The project has not been able to conduct a physical site visit until now due to the ongoing situation. PD had hoped the situation would have improved over the last period but that is not the case.

Northern Ethiopia has seen war in the last two years, during the projects activity, which impacted the Tigray and Amhara regions. The situation remains complex and ever-changing.

Below the PD has included documented reports of the ongoing situation.

The PD elects to continue to monitor the situation closely, as they have since the project's inception, and make arrangements for a physical VVB site visit at the earliest safe opportunity to do so.
