The site visit conducted by the local expert during the verification confirms the status of the project operation and demonstrates how the selected expert has any prior experience working in conflict zones/areas that pose a high risk to life and/or health or how this was managed.

The VVB shall ensure that no monitoring gaps exist within the eligible Monitoring Period. However, if gap(s) exist, the VVB shall ensure that conservative approach(es) have been applied and verified in line with section 3 of the Deviation Approval Requirements and Procedures (version 1.2) and overarching Gold Standard principles (as applicable).

The VVB shall ensure that the deviation detail and VVB opinion are included in the appropriate section of the monitoring and verification report (for the relevant Monitoring Period) and shall, through appropriate means at its disposal, evaluate the project's compliance with the above-mentioned conditions and provide its opinion in the Verification Report.

2 | Background information

Request: Request a deviation from the original site visit plan due to insecurity in the region.

As part of the fourth verification of project <u>GS5391</u> Ecomakala Virunga Energy project, a VVB audit was conducted to verify the outcome of the project during the fourth monitoring period (01/11/2020-31/10/2021).

The precedent VVB site visit was conducted between 06/02/2020 & 10/02/2020. As per paragraph 3.1.2 of Site Visit and Remote Audit Requirements and Procedures, a physical site visit is mandatory once every three years after the first physical site visit date. Hence, similar site visit was initially planned with the VVB between 01/02/2023 & 05/02/2023 (cf. confirmation email exchange from 08/11/2022 in document: '20221108_Email confirmation dates VVB site visit').

Meanwhile, the prevailing insecurity in the North Kivu Province and the city of Goma has made it unsafe for the project developer CO2logic and the VVB Carbon Check to proceed with the scheduled site visit as planned. Indeed during this period, a series of incidents (sources [1], [2]) perpetrated by the rebel group M23, including attacks on security forces and the civilian population, has created a highly volatile and unpredictable environment. These incidents posed significant risks to the safety and well-being of individuals, making it imperative to prioritize their security above all else.

On top, an official letter from the local government on the 11th of January 2023 canceled all visa applications for visitors to Goma due to ongoing military state of siege (see document: 'Letter visa suspension 20230111_with comments') . The cancellation was attributed to military movements and concerns for the safety of individuals in the area.

In the interim, an alternative means of engagement was found. A virtual meeting but with physical presence of local expert on site, to ensure verification on the project despite the physical limitations was conducted between 7th and 9th of March 2023.

The project developers are seeking for a temporary deviation regarding the application of <u>Site Visit and Remote Audit Requirements and Procedures</u> and will replan the site visit for the next verification (MP5) if the security situation allows the presence of international staff in the North Kivu province.

As a part of the 4th verification of Ecomakala Virunga Energy project, PP is requesting for the deviation request for not conducting the site visit due to insecurity in the North Kivu Province and the city of Goma region. As VVB has planned to conduct an onsite visit in the month of February 2023, however all visa applications got rejected "see document: 'Letter visa suspension 20230111". Due to the interim measure the virtual audit was done with the physical presence of the local expert. The entire audit is done as a hybrid.

This is the 4th performance certification of the project, for the monitoring period (01/11/2020 to 31/10/2021). VVB has considered the Remote Audit Requirements and Procedures, version 2.0 paragraph 3.1.2 for conducting the remote audit/hybrid audit. As VVB signed the contract with PP after this VVB plan to do audit as soon as possible, due to the Goma security condition (due to crime and civil unrest, Goma areas have increased risk), the local expert is unable to go onsite without any security and VVB unable to get visa approval. For the same reason the entire verification team were not able to get visa approval and hence must rely on local expert (Rogers Muganga) who conducted the entire survey physically, the sectoral expert is available remotely throughout the audit to guide the LE and involved in the survey of end users via remotely.

3.2.1 | Deviation assessment (to be completed by Project developer):

The project developers are seeking for a temporary deviation regarding the application of <u>Site Visit and Remote Audit Requirements and Procedures</u> as no physical site visit could be conducted in the three years after the last one (06/02/2020 - 10/02/2020). Instead, a virtual meeting with the physical presence of local expert in Goma office was held following the remote site visit requirements prescribed by Gold Standard (cf. FVR: 'CCIPL 730 GS FVR-22-07-2020-clean'). PD seeks to replan the site visit for the next verification (MP5) if the security situation allows the presence of international staff in the North Kivu province.
