The deviation request has been approved, as all the documents were submitted to SustainCERT before the end of the CDM crediting period, and the project developer has taken the necessary steps to complete the process on time.

SustainCERT is requested to issue the invoice, and the project developer should make the payment within the defined timeline.

The verifying VVB shall, through appropriate means at its disposal, evaluate the Project's compliance with the above-mentioned conditions and provide its opinion in the Validation Report.

SustainCert shall review both the PD's response and the VVB's assessment/opinion of the same and take appropriate steps.

We request that project GS11717 to be allowed to be transferred to Gold Standard. This project was registered with CDM, as project "CPA-MA-25-Madagascar Ethanol Stove Program"

The CDM Crediting period ended on 02/08/2023.

The project documents was submitted to SustainCERT and request for Preliminary review and design review prior to the end of the crediting period under CDM.

SustainCERT has informed us that the project cannot be transferred to Gold Standard because the CDM Crediting period has already expired and they have not received payment for the fee for preliminary review prior to the date of the expiry of the CDM Crediting period.

We request that the project is allowed to be transferred from CDM to Gold Standard as if the fee had been paid prior to the expiry of the crediting period, subject to the fee of \$900 is paid within 10 days of a new invoice being submitted to Green Development AS, or within 10 days after a positive reply on this deviation request.

2 Background information

We have a PoA registered with CDM. We have a number of CPAs implemented in 4 different countries under this PoA. The CPAs was registered in different times and with different crediting periods.

In April 2021 we started the process of trying to transfer the PoA and the projects from CDM to Gold Standard. The Registration / Design Certification date for the GS PoA was 17/01/2023. The GS ID for the PoA is GS11574.

We have submitted the documentation to SustainCERT for them to carry out combined preliminary review and design review as required for transferring the projects from CDM to Gold Standard. For the project in question this was done before the end of the crediting period under CDM.

We have also submitted a Deviation request for some of our other projects in which the CDM Crediting period ended on 27/08/2021. Gold Standard approved this deviation request, COVID_Dev 273, and concluded that these projects could be transferred to Gold Standard with a crediting period starting on 28/05/2021, under Gold Standard if a validation site visit for the renewal of the crediting period could be done before 28/05/2023. The verification site visit for these projects was done prior to 28/05/2023. Project GS11717 was however not included in Deviation request, COVID_DEV 273, as we had assumed that the project GS11717 could be transferred within a year from this process started. We now realized that this was an unrealistic assumption and that we should have understood that it would take more than a year to transfer projects from CDM to Gold Standard.

It should be noted that we have been informed by SustainCERT that an invoice was submitted to us on 29/06/2023 with due date on 13/07/2023. Unfortunately, this was not paid, but we have also not received any follow up from SustainCERT to advise us to make a payment for this invoice, so that we could have paid this invoice before the expiry of the CDM Crediting period (on 02/08/2023). Please note that we have received several 100 emails from SustainCERT including at least 104 emails from SustainCERT since the beginning of June 2023, during the summer holiday, which might be way the invoice was not paid.

Please also know that we have made 13 payments to Gold Standard and Sustain CERT in relation to the transfer of our projects from CDM to Gold Standard. In total we have made a payment of \$157,571.10 so far, even though we have not managed to complete the transfer of any projects to Gold Standard so far during the two years we have tried to do so.

We think that it is strange that SustainCERT or Gold Standard does not follow up with request for payment for new invoices when we did fail the make the payment by the due date. Particularly as this invoice was sent to us as one out of more than 100 emails that was sent to us during the summer holiday and considering that we have already made payments of \$157,571.10 for the transfer of the projects under our program from CDM to Gold Standard. If a follow up reminder of the payment due had been sent to us, we would not have had to invest resources in preparing this Deviation and Gold Standard would not have had to use resources to assess this deviation request.

We would also like to point out that we had been warned about the complexity of transferring the projects from CDM to Gold Standard. Because of this we recommended to Gold Standard during a workshop with Gold Standard, that Gold Standard provided technical assistance for projects that wanted such assistance. We pointed out that we of course would pay for such assistance. Gold Standard did however decide that Gold Standard would not provide such support to projects, even though it is clear that such technical support would not impose a cost to Gold Standard, but would greatly reduce the resources that Gold Standard and SustainCERT needed to use for assessment of documents for transferring the projects to Gold Standard. Such technical support would also have saved us, as a project developer, a lot of time and cost, and would have enabled our project to expand more than what is now the case. Such support would in other words have contributed substantially toward the Sustainable Development Goals. If such support had been made available to us, we feel confident that our projects would all have been transferred to Gold Standard by now, and then this Deviation request would not have had to be part of our process of transferring our projects to Gold Standard.
