3 Deviation detail

3.1 | Description of the deviation:

This is the sixth verification covering the 1st CP and first verification covering the 2nd CP which is undergoing under GS with the Monitoring period 01/01/2021 to 31/12/2022. According to the requirement, PRINCIPLES & REQUIREMENTS, 5.1.39, "Transparent, annual update reports need to be provided for Projects that have achieved the Project Design Certification stage or have successfully transitioned to Gold Standard for the Global Goals. An annual report shall be submitted for each monitoring year by end of

next calendar year for which verification is not completed. If a verification is in progress but not completed, then an Annual Report is still required by the end of calendar year" & 5.1.40 "Failure to provide Annual Reports as required shall result in the decertification of the Project". Note that PP has undergoing the GS Verification for the monitoring period 01/01/2021 to 31/12/2022. In light of the challenges described below, we request a deviation to continue verification process of the project without decertification of the Project.

The deviation does not attract any kind of risk upon environmental integrity and all the SDG contributions are achieved in-line with the registered PDD.

3.2 | Assessment of the deviation:

3.2.1 | Deviation assessment (to be completed by Project developer):

The subject project activity owned by Orange Mamatkheda Wind Private Limited (OMWPL). The project attained Design Certified Status on 21/12/2015 (For 1st CP) and 26/07/2022 (For 2nd CP), and PA has ongoing verification for the monitoring period 01/01/2021 to 31/12/2022. Further, PP has also initiated VVB appointment process for verification of PA. Since the project owner was serious towards verification therefore the required procedure has initiated.

The delay in submission to annual report due to the unique difficulties the project had to faced:

Change of team: The management has been changed from the orange group to the Greenko group in year 2021, further management and team shifting took more than a year. The new team's lack of information regarding the guidelines and reshuffling resulted in delayed submission of annual report. At the same time COVID19 pandemic also impacted the day to day working of project owner.

Change of Project Representative: Previously the project representative for the Monitoring period was "Kosher Climate India Private Limited" which was changed in Jan 2023 from Monitoring period 01/08/2020 to 31/12/2020, and hence as stated above, due to both of the reasons the annual report was missed.

The project proponent from the very beginning has tried its level best to ensure all guidelines are being met.

3.3 | Impact of the deviation:

3.3.1 | Impact assessment (to be completed by Project developer):

The project proponent has not claimed credits after the change of team and management. The project needs carbon credits to continue its operation. In the absence of carbon credits, the project will not be able to sustain itself.

The deviation of this project lies in the deviation of the submission of annual report. During the delay period, the project owner has continued to monitor all parameters which were validated and approved during the verification. The above deviation will not cause any impact upon the data quality or attract any potential risk on GS related to any issuance or any other material impact affecting the quality of the project and thus no potential risk is attributed to GS Project activity in particular. The deviation requested adheres to the Principles and Requirements set forth by GS4GG and complies with:

Environmental Integrity- The GSVER's generated from the project activity are not overestimated because of deviation and conservativeness are ensured.

Contribution to Sustainable Development Goals- SDG contributions that the project is designed to achieve are in line with GS4GG requirements and the above deviation does not have any potential impact upon the certified SDG's claimed during the current crediting period.

Safeguarding Principles and requirements- The deviation does not create any impact upon the safeguarding principles and requirements set forth by GS4GG.
