#### 3.1 | Description of the deviation:

3.1.1 | Deviation detail (to be completed by Project developer):

The VVB is not able to perform an on-site visit for the audit of MP11 (01/12/2021 -

28/08/2022) as Lesotho has suspended all Visa applications citing the outbreak of the Corona Virus as reason:

"Due to the outbreak of the Corona Virus (COVID-19) and its effects, applicants are advised to suspend all visa application plans until further notice."

Regardless of the actual underlining reason the fact remains that no visa applications are possible and it is unclear when the Visa application suspension will be lifted.

Due to this, travelling to Lesotho is not possible for the VBB. A delay of the on-site audit is not possible as the Project developer has obligations towards their client to deliver the VERs in time.

Therefore, the VBB is planning to perform a remote audit with the assistance of a local expert.

3.1.2 | VVB opinion (to be completed by VVB, if applicable):

VVB in coordination with CME tried to get E-Visa for the onsite audit for the project. However, E-visa for Lesotho is suspended due to Covid-19 outbreak in the country<sup>1</sup>. Further, VBB tried to apply for a Visa directly through the embassy with the help of a travel partner. However, Lesotho Embassy has instructed to physically submit the visa application to the Immigration Department of the Ministry of Home Affairs, Kingdom of Lesotho. When CME went there to deliver the VISA document, they got reply from immigration that they are issuing full work permits there (e.g. for 2 years actually working in Lesotho) and no standard visiting tourist/business visas. The mails of conversation from the embassy is attached with the form.
