# 3.1 | Description of the deviation:

# 3.1.1 | Deviation detail (to be completed by Project developer):

This project was recently approved for a deviation request to deviate from a physical site visit requested by the ongoing Verification reviewing VVB, in place of a remote audit due to the ongoing the civil conflict directly in the project area

The project developer is now requesting a deviation against the remote audit as the situation on the ground has since escalated and does not allow for an effective or safe remote audit to be conducted. Mobile phone networks and internet have been down in

the region for the last months. A standard desk based review is requested in it's place for this verification.

Military fighting and tension is still ongoing in the project area and has only escalated since the last deviation submission and approval.

Our project partner in the region has expressed concerns for the safety of the team to conduct the remote audits effectively.

Random Sampling was conducted by the VVB to consider which HHs would be required for the remote audit, however the project partner confirmed to the project developer and VVB that these would be impossible due to the ongoing situation.

The project was design certified on 09/04/2021 and the CP start date is in 2020. A remote audit was successfully carried out on 14th January 2022 as part of the previous verification process with no concerns raised.

The project has not been able to conduct a physical site visit due to the ongoing situation. PD had hoped the situation would have improved over the last period but that is not the case.

Northern Ethiopia has seen war in the last two years, during the projects activity, which impacted the Tigray and Amhara regions. The situation remains complex and ever-changing.

The control of towns, regions and strategic points in the project area has changed between Fano forces and federal forces since the start of August 2023. Quoted as an "ever-escalating conflict in Ethiopia's Amhara region" (September 29, 2023) conflict persists and tensions remain high in the region (September 26, 2023). A senior member of the Ethiopia Human Rights Defenders Centre went as far as saying "the Amhara region has escalated into full-scale warfare, with severe consequences for civilians" (September 26, 2023).

According to residents and eyewitnesses in the Amhara region, the conflict has further spread to various woredas (districts) of the region which has exposed civilians to greater risk, including extrajudicial killings by state security forces (September 18,

2023).

The federal government maintains that this conflict can be managed through "might", despite calls by civil society, religious institutions, and the international community to look for a peaceful resolution. Fano meanwhile have refused local reconciliation initiatives, instead looking to international actors to create a space for further negotiations.

For the purpose of this already significantly delayed review, the PD requests for the review to be able to continue as a desk-based review by the PDD.

The conflict and ongoing situation in the region is beyond the PD's and implementation partners control; however, the nature of this deviation is temporary, and a future physical site visit will be conducted when deemed safe and appropriate. The implementer has other similar projects within Ethiopia which follow the same design where successful OO site visits have been achieved.

A desk based audit, to be conducted by CarbonCheck VVB as part of the current ongoing verification will allow for comparable findings- they have a track record of high quality reviews.

Opportunity will be made available to the VVB to interview the PDD and implementation partner if required.

A desk based review by the VVB will be effective and appropriate in verifying the project for this MP. Additional opportunity to interview the PD and project implementer will support this.

Desk based reviews were successful during COVID periods where physical visits and remote audits were not viable. This situation should be considered much the same.

Regional issues can impact the project's ongoing activities- however PD is confident in how the project has been managed until now considering the challenges and the implementers success in running successful GS carbon projects for many years.

The regional situation only compounds the need for projects like this locally and successful verification and issuance is critical to ensuring the projects ongoing funding of safe water provision for local communities
